Managing Prosthetic Complications

## GABRIELLE JACKSON, DDS, MS



Dr. Jackson, originally from Chicago, completed her undergraduate biology degree at Bradley University in Illinois. She earned her DDS at the University of North Carolina at Chapel Hill-where she also completed her three-year post-graduate residency program earning her Master's in Oral Biology and Prosthodontics.

Dr. Jackson began her career serving patients in an implant center, then transitioned into private practice and is currently practicing at Dallas Prosthodontics. She is especially skilled in full-mouth rehabilitations, implant-supported prosthetics and cosmetic dentistry.

This presentation discusses common implant-related prosthetic complications and strategies to prevent and best manage complications should they arise. Diagnostic and treatment planning failures contribute to complications but there are also patient factors at play. This lecture highlights problems of poor technical decision-making and execution in addition to common component failures. Clinical cases with prosthetic failures are presented to illustrate different scenarios and situations that can occur when planning and placing implantsupported prostheses.
